CONAI: adjusted EPR Fee for Paper and Wood Packaging

MILAN, JULY 2025 – after the regular monitoring of the financial situation of the packaging material consortia, **CONAI** initiated talks with the consortia **Comieco** and **Rilegno**, which resulted in the Board of Directors making the decision to **adjust the EPR fee** for **paper** and **wood** packaging.

From the **1st October 2025** the base EPR fee for **paper** packaging shall be reduced from €65.00/tonne to **€45.00/tonne**.

The revision downward was made possible due to improvements in pricing for feedstock from 2024 and the first half of 2025 over expected trends, despite there being an increase in the quantities of paper and cardboard from municipal collections under agreement with Comieco.

The EPR fee supplements already set will be added to the new base EPR fee, as summarised in the table:

The EPR fee for wood will increase from €9.00/tonne to €10.00/tonne, starting from 1st January 2026. This increase is part of a long-term Consortium economic and financial pathway.

This readjustment will also have an effect on the flat-rate/simplified procedures for filled packaging imports, as summarised in the table.
